

Know All Men by These Presents:

in the State aforesaid, That we, Lide L. Richbourg and Lila M. Richbourg in consideration of the sum of Twelve Hundred & No/100 (\$1,200.00) - -- - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said ROBERT A. CRAWFORD, JR. and NAN T. CRAWFORD:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Butler Township, being known and designated as Lot Number Twenty-five (25), as shown on plat of property of Morningside, as made by Dalton & Neves, Engineers, in December 1952, which plat is of record in the R. M. C. Office for said County and State in Plat Book "EE", at pages 2 and 3, reference to which plat is hereby made, said lot of land being described by metes and bounds, as follows, to-wit:

BEGINNING at an iron pin on the Northeastern side of Richbourg Road at the joint front corner of Lots Nos. 24 and 25, as shown on said plat, and running thence North 43-28 East one hundred ninety-seven and six-tenths (197.6) feet to an iron pin; thence South 47-38 East one hundred twenty-five (125) feet to an iron pin at the corner of Lot No. 26; thence South 43-16 West along the dividing line between Lots Nos. 25 and 26, one hundred ninety-nine and seventenths (199.7) feet to an iron pin on the Northeastern side of Richbourg Road; thence along the Northeastern side of Richbourg Road North 46-30 West one hundred five and four-tenths (105.4) feet to an iron pin; thence continuing along the said Northeastern side of Richbourg Road North 47-24 West twenty and fivetenths (20.5) feet to the place of beginning.

This property is subject to the restrictions and reservations set out in an instrument of writing dated January 20, 1953, and recorded in the R. M. C. Office for said County and State in Deed Book 470 at page 369, reference to which is hereby expressly made as a part of this conveyance, and is subject to the following additional restriction: "All tanks, barrels and containers for fuel oil shall be placed below the surface of the ground or concealed".
