Holcombe and Julia S. Holcombe, herein called grantees, all that tract of land in Greenville County, S. C., which is shown as a part of the property of J. P. Rosamond on plat by Pickell & Pickell, Engineers, dated April 27, 1945, revised October 27, 1947, and lying immediately southwest of and adjacent to a tract of 28.6 acres conveyed to the grantees by the grantor June 14, 1952, by deed recorded in Book 457 at Page 389. It being the intent of this deed to convey all of the remainder of said tract which contained 57.92 acres originally, and the tract herein conveyed contains 29.32 acres more or less and is described as follows:
