

All that lot of land situate on the southeast side of North Estate Drive near the City of Greenville in Greenville County, S. C., being shown as Lot 51 on plat of Crestwood, Inc., made by J. C. Hill, Surveyor, February 28, 1949, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "S", Page 189, and having according to said plat the following metes and bounds, to-wit:
