Mitchell, having the following courses and distances: Beginning on a stone and iron pin on the western edge of said road, corner with other lands of I.F. Mitchell, and runs thence with said road N. 37.50 W. 181 feet to an iron pin, I.F. Mitchell's corner; thence S. 34.18 W. 222.8 feet to an iron pin, I.F.
