

BEGINNING at an iron pin on the Easterly side of Sycamore Drive, said pin being located at a point 400 feet north of the northeasterly intersection of Sycamore Drive and Brook Street, and said pin also being the joint front corner of Lots Nos. 150 and 151, and running thence along the joint line of said Lots S 69-42 E 240 feet to an iron pin on the westerly side of Ridgeway Drive; thence along the Westerly side of Ridgeway Drive N 14-32 E 192.8 feet to an iron pin, the joint rear corner of Lots Nos. 148 and 149; thence along the joint line of the last mentioned Lots S 89-50 W 266.5 feet to an iron pin on the Easterly side of Sycamore Drive; thence along the Easterly side of Sycamore Drive around a curve, the chord of which is S 2-24 E 50 feet to an iron pin, the joint front corner of Lots Nos. 149 and 150; thence continuing along the Easterly side of Sycamore Drive around a curve, the chord of which is S 11-36 W 50 feet to the point of beginning.
