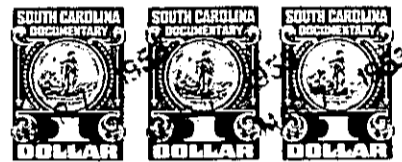

All that certain lot of land in Greenville County, State of South Carolina, in the City of Greenville, being a portion of Lots Nos. 40 and 41 of Block C of Augusta Court as shown on plat made by R. E. Dalton, Engineer, Apr. 1923, and recorded in the R. M. C. Office for Greenville County in Plat Book F, at page 124, and being Lot No. 4 on a plat made by J. C. Hill, L. S., March 1953, subdividing said Lots Nos. 40 and 41, Block C, and having the following metes and bounds according to the J. C. Hill plat, which is to be recorded in the R. M. C. Office for Greenville County:

BEGINNING at an iron pin on Phillips Lane, at corner of property now owned by the grantee, and running thence with the northwest side of Phillips Lane N. 47-10 E. 60 feet to an iron pin; thence N. 41-30 W. 218.2 feet to an iron pin in line of Lot No. 39, Block C, on plat first above referred to; thence with line of said lot, S. 25 W. 65.6 feet to iron pin; and thence S. 41-30 E. 192.8 feet to the beginning corner.
