All that piece, parcel or lot of land, situate, lying and being in the City and County of Greenville, State of South Carolina, being known and designated as Lot No. 24, as shown on the plat of College Heights, recorded in the R. M. C. Office for Greenville County in Plat Book P, at page 75 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southwestern side of Winthrop Avenue at the joint front corner of Lots Nos. 24 and 25 and running thence with the line of Lot No. 25, S. 56--50 W. 144.2 feet to an iron pin in the line of Lot No. 26; thence with the line of Lot No. 26, S. 33-10 E. 75 feet to an iron pin on the northern side of Princeton Avenue, joint corner of Lots Nos. 24 and 26; thence continuing with the northern side of Princeton Avenue, N. 56-50 E. 118.9 feet to an iron pin; thence following the curved intersection of Princeton Avenue and Winthrop Avenue, the chord of which is N. 11-55 E. 34.6 feet to an iron pin on Winthrop Avenue; thence with Winthrop Avenue, N. 33-00 W. 50 feet to the point of beginning.
