in and with, goods, weres, and merchandise, and choses in action; and

(g) To engage in, do and transact all and every kind of business that she

may think proper; and

(h) To make, sign, execute, seal, saknowledge and deliver all such deeds, leases, and assignments of leases, covenants, indentures, agreements, hypothecations, bills of lading, bonds, notes, receipts, evidences of debt, releases, and satisfactions of mortgage, judgments, and other debts, and such other instruments whatsoever kind and nature, as may be necessary, or proper, in the premises.

And I, the said ETHELYN BERRY SMITH, hereby ratify all that my said

attorney may lawfully do, or cause to be done, by virtue hereof.
