Know All Men by These Presents:

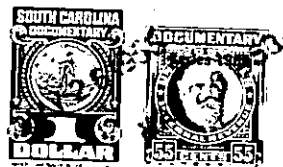
That I, Kate C. Fair, in the State aforesaid, in consideration of the sum of Four Hundred and No/100 (\$400.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Charles T. Moore, his heirs and assigns forever,

"All that certain piece, parcel or lot of land on the Northern side of Potomac Avenue in the City of Greenville, Greenville County, State of South Carolina, being shown as the Western one-half of lot No. 186 on plat of Pleasant Valley, recorded in Plat Book P at Page 22, and Plat Book EE at Page 5, and being more fully described as follows:

"BEGINNING at an iron pin on the North side of Potomac Avenue, at the center of lot No. 186 and at the corner of lot this date conveyed to Davis E. Cole, and running thence with the line of the Cole lot, N. 0-08 W. 160 feet to iron pin; thence S. 89-52 W. 30 feet to an iron pin at rear corner of lot No. 187 now owned by Charles T. Moore; thence with line of said lot S. 0-08 E. 160 feet to iron pin on Potomac Avenue; thence with the Northern side of Potomac Avenue, N. 89-52 E. 30 feet to the point of beginning, this being a portion of land conveyed to grantor by deed recorded in Volume 407 at Page 41."
