Know All Men by These Presents:

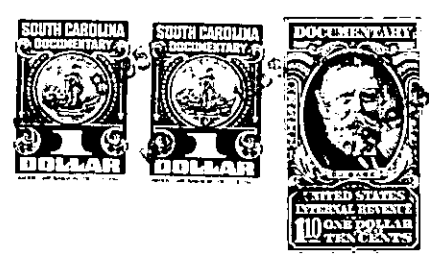
That I, Sumlar Hall in the State aforesaid, in consideration of the sum of Seven Hundred Fifty and No/100 (\$750.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Mary E. McCoy, her heirs and assigns forever:

All that lot of land in Greenville County, State of South Carolina, in the City of Greenville, being known and designated as lot 15, as shown on a plat of a subdivision for Sumlar Hall, prepared by Pickell & Pickell, Engrs., May 1950, and being more particularly described according to said plat as follows:

BEGINNING at an iron pin in the West side of Palm Street, joint front corner of lots 14 and 15, which pin is 92.9 feet North of the intersection of Palm Street and Nickle Street, and running thence with joint line of said lots, S. 86-24 W. 101 feet to an iron pin; thence N. 3-49 W. 50 feet to an iron pin, rear corner of lot 16; thence with line of said lot, N. 86-24 E. 102.4 feet to an iron pin in the Western side of Palm Street; thence with said street, S. 1-53 E. 50 feet to the point of beginning.
