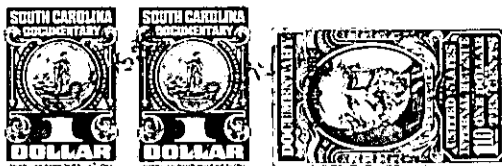

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Annie Bell Stevens, her heirs and assigns forever

All that certain lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lot No. 33 of the Property known as Nicholstown Heights, and having the following metes and bounds according to Plat recorded in R. M. C. Office for Greenville County in Plat Book M, page 4:

BEGINNING at a stake on the west side of Mims Avenue 40 feet from the intersection of Watson Street and Mims Avenue, at corner of Lot No. 32, and running thence with line of Lot No. 32, S. 89-15 W. 110 feet to a stake at joint corner of Lots Nos. 6, 7, 32 and 33; thence with the rear line of Lot No. 6, N. 0-45 W. 40 feet to a stake at corner of Lot No. 34; thence with line of Lot No. 34, N. 89-15 E. 110 feet to stake on the west side of Mims Avenue; and thence with Mims Avenue S. 0-45 E. 40 feet to the beginning corner.

The above described lot of land is one of the lots conveyed to me by Charles A. Chapman by deed dated June 28, 1951, and recorded in Book 438, page 248.

It is understood and agreed that the grantee will pay taxes for the year 1953.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
