Chamlee, and running thence N 89 - 52 W 5.1 feet to a point; thence N 1 - 15 E 67.0 feet along Summit Drive to a point; thence S 87 - 32 E 5.1 feet to a point; thence back along Summit Drive S 1 - 15 W 67.0 feet to the beginning corner

The strip of land above described is to be used for the purpose of widening Summit Drive.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and Its successors Heirs and Assigns forever.
