C., lying on the south side of the road known as the Lee Road, being bounded on the north by the said road, on the east and south by other lands of myself, and on the west by lot J. D. Case, and having the following courses and distances, to wit:-Beginning on an iron pin in the center of the said road, joint corner of said J. D.
