S. Richardson, Claude L. Sprouse, E. Paul Foster, Roy Whitmire, J. C. Staton and Raymond Johnson, being the BOARD OF DEACONS OF THE SLATER BAPTIST CHURCH:

All that certain piece, parcel or lot of land in the Village of Slater Manufacturing Company, Slater, Greenville County, S. C., as shown on a plat of property of the Slater Manufacturing Company, showing additions to lots along Whitney Street made by Pickell & Pickell, Engineers, March, 1953, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book DD at page 121, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at the joint rear corner of Lots Nos. 1 and 2 of Block B and running thence N. 87-34 E. 100 feet to a point; thence S. 2-27 E. 19 feet to a street; thence along said street S. 60-04 W. 112.2 feet along said street to the rear corner of Lot No. 1, Block B; thence along the rear line of Lot No. 1 N. 2-27 W. 70 feet to the point of beginning.

The property herein conveyed is subject to all the restrictions, reservations, easements, rights of way and covenants as set forth in deed from S. Slater & Sons, Inc. to I. V. Jones, W. G. Hill, M. C. Hembree and Boyd Godfrey, constituting and being the Board of Deacons of The Slater Baptist Church, dated October 1, 1940, and recorded in the R. M. C. Office for Greenville County, S. C., in Deed Volume 227 at page 41, and conveying Lot No. 1 of Block B of which the within described lot hereby becomes a part. It is intended by this conveyance to make the within described property an addition to and part of Lot No. 1 of Block B already owned by the grantees so that all of said restrictions, reservations, easements, rights of way and covenants shall apply to the aggregate as one lot and said lot as hereby enlarged is subject to the additional restriction that only one single-family dwelling shall be erected or maintained on said lot as so enlarged.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and their successors in office, ~~and~~ heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
