All that certain piece, parcel or lot of land situate, lying and being in the tate of South Carolina, County of Greenville, and in Greenville Township, being nown and designated as Lot No. 2 of Cordell Solding.

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, being known and designated as Lot No. 2 of Cordell Subdivision No. 10 as shown on plat thereof made by C. C. Jones in December, 1952 and recorded in the R. M. C. office for Greenville County in Plat Book BB, at page 84, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Bent Bridge Road at the joint front corner of Lots Nos. 1 and 2, and running thence along the north side of Bent Bridge Road, S. 66-34 W. 75 feet to an iron pin at the joint front corner of Lots Nos. 2 and 3; thence along the joint line of said lots, N. 23-26 W. 183.1 feet to an iron pin at the rear corner of said lots in line of property now or formerly belonging to E. B. Hinton; thence along the line of that property, N. 84-10 E. 78.5 feet to an iron pin at the joint rear corner of Lots Nos. 1 and 2; thence along the joint line of said lots, S. 23-26 E. 159.5 feet to the beginning corner; being a portion of the property conveyed to grantor corporation by Louise Earle, et al. by deed dated September 25, 1952 and recorded in the R. M. C. office for Greenville County in Vol. 463, at page 503.
