C., City View Water and Sewer District Commission, Greenville Traction Company, Duke Power Company and its predecessors, Southern Power and sewer pipe lines (other than house lines), electric light and power lines, including all pipe (other than house water and sewer lines), valves, fittings, protection, electric light and power lines, and other apparatus and equipment used in connection with, or forming a part of, the water, fire located together with rights of way and easements to go upon the land for the purpose of maintenance, repair, alteration, replacement, constructed or to be constructed, and to relocate certain of such lines and systems aforesaid and of certain other water, sewer, electric, telephone and street trolley in Monaghan Mills Village and to operate and maintain the lines as so relocated, all as will more fully appear by reference to the records in the R.
