Pryor and Fay B. Pryor their Heirs and Assigns forever;

All that certain piece, parcel or lot of land lying, being and situate in the County and State aforesaid, Fairview Township and in the Town of Fountain Inn, known and designated as Lot No. 12 on a Plat prepared by W. J. Riddle Surveyor, March 28, 1952 (Lots Nos 9 to 14 on said plat by L. P. Slattery, Engineer, March 19, 1953, said Plat of record in the Office of the R. M. C. for Greenville County, S. C., in Plat Book "D D" Page 99, and having according to said plat the following courses and distances, to-wit: Beginning at an iron pin on the East side of a new Street (now known as Weathers Circle), joint front corner with Lot No. 13 on said Street and running thence with said Street N. 21-23 E.
