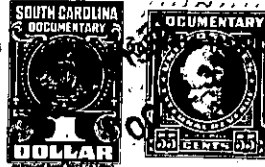

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C. L. King his heirs and assigns forever.

All that piece parcel or lot of land near Simpsonville, S. C., known as lots 40 and 41 on a plat of property made for the D. N. Mayfield Estate, by J. G. Burce Eng., Nov. 4, 1952, and recorded in Greenville County R. M. C. Office in plat book 60 page 199, and having the following metes and bounds according to said plat.

Beginning at a stake on the North side of a hard surface road at the corner 42 and running N. 72-05 W., 140 feet along said road to a stake at the corner of lot 39; thence N. 17-55 E., 197 feet to a stake at the corners of lots 39 and 33; thence S. 72-05 E., 140 feet to a stake at the corner of lot 42; thence S. 17-55 W., 197 feet to the beginning corner.

- The above property is conveyed on condition and subject to the following. 1. That no house or other building shall be erected any closer than 40 feet to the road on which the property fronts. 2. There shall be on junk yards placed on the property, nor any alcoholic beverages sold thereon.
