County State of South Carolina, located about two miles southeast from Mountain View School, south from the Few's Bridge Road, lying immediately to the rear of the present lot of the said Gum # Springs Pentecostal Holiness Church, being bounded on the north by the said county on the east by lands of Mrs. Lena Barton and on the south and west by other lands of J. A. Stewart, and being a part of the same land that was conveyed to me by deed from Joseph Hall, Executor, of the Last Will and Testament of L. K. Hall, deceased, and being better known as a part of the L. K. Hall place, and having the following courses and distances, to wit:-

Beginning on an old iron pin, joint corner of the original church lot, and runs thence S. 17-40 W. 35 feet to a stake; thence S. 63-44 E. 166 feet to an iron pin and Hickory (gone), joint corner of the two former parcels of the said church lot; thence with one of the original lines of the original first lot, S. 85-15 E. 185.6 feet to a stake in a dirt road; thence with this road and the line of Mrs. Lena Barton, S. 16-27 E. 43.8 feet to a stake in the said road and on the Mrs. Lena Barton line; thence a new line, N. 88-02 W. 223.3 feet to an iron pin, new corner, said corner being seven (7) feet west from the water line to the well; thence N. 61-30 W. 194 feet to an iron pin, new corner; thence N. 42-30 E. 85 feet to the beginning corner, containing Forty Four One-hundredths(0:44) of one acre, more or less.

ALSO I am conveying a Right of Way for the water line from the church lot to the well and an area around the well having the following description: Beginning on a point over the water line, said point being S. 88-02 E. 7 feet from an iron pin corner, and runs thence from the said point on the line of the above described lot, S/19-45 W. a distance of 213 feet to the center of the well. The strip in this right of way is 2 feet in width and 213 feet in length. Also a square area around the well is included in this right of way and is to be 20 feet square. If the water line is abandonded as a source of supplying water to the church for all of its needs, then the right of way and the 20 feet square around the well is to revert to me, my Heirs and Assigns.
