KNOW ALL MEN BY THESE PRESENTS, That Local Home Builders Inc.

a corporation chartered under the laws of the State of South Carolina
and having its principal place of business at

of the sum of Eleven Thousand, Two Hundred, Fifty and No/100 Dollars,
to it in hand duly paid at and before the sealing and delivery of these presents by the grantee
hereinafter named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and
released, and by these presents does grant, bargain, sell and release unto
Teddy Ray Adams, his heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as Lot No. 25 according to a plat of Cordell Subdivision No. 10 prepared by C. C. Jones, C. E., recorded in the R. M. C. office for Greenville County in Plat Book BB, at page 84, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Cornell Court at the joint front corner of Lots 24 and 25, and running thence with the joint line of said lots, S. 27-37 W. 227 feet to an iron pin; thence S. 72-10 E. 61 feet to an iron pin at the joint rear corner of Lots 25 and 26; thence along the joint line of said lots, N. 30-17 E. 216.7 feet to an iron pin on the southwestern side of Cornell Court; thence along Cornell Court, N. 62-30 W. 70 feet to the beginning corner; being a portion of the property conveyed to grantor corporation by Louise Earle and India E. Pepper by deed dated September 25, 1952 and recorded in the R. M. C. office for Greenville County in Vol. 463, at page 503.
