to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Thomas P. Rhyne, Jr.,

ALL THAT PIECE, PARCEL OR LOT OF LAND, with buildings and improvements thereon, in the City of Greenville, Greenville County, State of South Carolina, on the South-west side of Stephen Lane in a subdivision of the Central Development Corporation, being known and designated as Lot No. 108, said lot being more particularly described according to a plat of property of Central Development Corporation prepared by Dalton and Neves and recorded October 23, 1951 in the R.M.C. Office for Greenville County in Plat Book Y, at Pages 148-149, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest side of Stephen Lane, which pin is a joint front corner of Lots 107 and 108, and running thence with the Southwest side of Stephen Lane S. 14-23 E. 50.1 feet to an iron pin on the Southwest side of Stephen Lane; thence continuing with the Southwest side of Stephen Lane, S. 7-49 E. 40 feet to an iron pin, joint front corner of Lots 108 and 109; thence with the line of Lot 109, S 62-41 W. 191.5 feet to an iron pin on the Northeast line of Lot 110, and which is also the joint rear corner of Lots 108 and 109; thence with the line of Lot 110, N. 29-07 W. 45 feet to an iron pin, joint rear corner of Lots 107 and 108; thence with the line of Lot 107, N. 51-47 E. 221.2 feet to the beginning corner.
