All that piece, parcel or lot of land lying and being situate in Greenville County, State of South Carolina and lying in that section known as Sans Souci and being known and designated as Lot No. 15 and a 6-foot strip off of the East side of Lot No. 16, according to plat of the B. E. Geer property, recorded in the office of Register Mesne Conveyance in and for Greenville County in Plat Book G, page 237 and having the following metes and bounds, to-wit:
