That I, Donald E. Baltz in the State aforesaid, in consideration of the sum of Three Thousand Five Hundred (\$3,500.00) - DOLLARS, and assumption of mortgage to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Richard T. Evington,

All that certain lot of land in the city of Greenville, county of Greenville, state of South Carolina, being known and designated as lot No. 14 of the Donald E. Baltz property shown on plat thereof recorded in the R. M. C. Office for Greenville County in plat book Y at page 46 and having according to a recent survey made by J. M. Beeson, Engineer, November 1953, the following metes and bounds, to-wit:

Beginning at an iron pin on the southwest side of Don Drive, the joint front corner of lots 14 and 15, and running thence with the joint line of said lots S. 32-07 W. 150 feet to an iron pin rear corner of lot No. 25; thence with the rear line of said lot N. 57-53 W. 75 feet to an iron pin rear corner of lot No. 13; thence with the line of said lot N. 32-07 E. 150 feet to an iron pin on the southwest side of Don Drive; thence with the southwest side of said street S. 57-53 E. 75 feet to the beginning corner.

Being a portion of property conveyed to Donald E. Baltz by Lucy W. Gifford by deed dated January 31, 1951 recorded in volume 428 page 170 of the R. M. C. Office for Greenville County.

The grantee assumes payment of that certain mortgage given by Donald E. Baltz to W. W. Wilkins in the amount of \$6,000 dated November 21, 1952 recorded in mortgage volume 546 at page 214.
