

Bundy and Ella Mae N. Bundy, their heirs and assigns:

All that certain piece, parcel or lot of land, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the Northwest side of Princeton Avenue, being shown as all of Lot No. 27 on plat of property of College Heights, prepared by Dalton & Veves, Engineers, in August, 1946, which plat is recorded in the R. in. C. Office for Greenville County, S. C. in Plat Book P, at Page 75, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwest side of Princeton Avenue at the joint front corner of Lots Nos. 26 and 27; thence along line of Lot No. 20, N. 33-10 V. 150 feet to an iron pin; thence S. 56-50 W. 75 feet to an iron pin; thence along line of Lot No. 28, S. 33-10 E. 150 feet to an iron pin; thence along Princeton Avenue, N. 56-50 E. 75 feet to point of beginning.
