

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said · Louis B. Reese, His Heirs and Assigns:

All that certain piece, parcel or lot of land, situate, lying and being in County of Greenville, State of South Carolina, on the South side of Sir Abbott Street and being shown as all of Lot No. 103 on plat entitled "Sherwood Forest," prepared by Calton & Neves, Engrs., in August, 1951 which plat is recorded in the R. L. C. Office for Greenville County, S. C. in Plat Book GG, at pages 2 and 3, and having according to a recent plat and survey of the property of Louis B. Reesc, prepared by R. K. Campbell, Registered Surveyor, on November 2, 1950, the following wetes and bounds, to-wit:
