Clyde South and Lucille R. South, their heirs and assigns forever

All that certain piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 19 and the adjoining part of Lot No. 20, Block G, on a plat of Highland Terrace, said plat recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book K, at page 121 and being more fully described as follows, to-wit:

Beginning at an iron pin on the southern edge of Montclair Avenue (formerly Fairview Avenue), said pin being 267.6 feet from the southeast corner of the intersection of Montclair Avenue and Townes Street, and running thence, S. 9-52 W. 150 feet to an iron pin on the northern edge of a 15 foot alley, said pin being the joint rear corner of Lots Nos. 18 and 19; thence S. 80-08 E. 75 feet along the northern edge of said alley to an iron pin, center of Lot No. 20; 9-52 E. 150 feet to an iron pin on the southern edge of Montclair Avenue; thence N. thence N. 80-08 W. 75 feet along the southern edge of Montclair Avenue to an iron pin, the point of beginning.

Being the same lot of land deeded to the grantor by deed of Nesbitt Q. Cline and Martha A. Cline by deed dated February 25, 1953 and recorded in the R. M. C. Office for Greenville County in Deed Book 473, at page 195.
