said parcels of land and future improvements thereto and the maintenance thereof, including the cost of installing and maintaining culverts for such drains and ditches as shall be desired by the second party.

3. That the said parcels of land shall be otherwise subject to all of the terms and conditions of said agreement dated April 17, 1953.

IN TESTIMONY WHEREOF, the first party has caused these presents to be executed in its corporate name and behalf by its officers duly authorized in its behalf, and the second party has likewise caused these presents to be executed in its corporate name and behalf by its CITY MANAGEM, and the same to be attested under its corporate seal by its Clerk under and by virtue of a resolution or ordinance passed and adopted at a meeting of said City Council of the City of Greenville on the Adday of Caroline, A.
