to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Annie Belle H. Carey, her heirs and assigns:

All that piece, parcel or lot of land in the City of Greenville, State of South Carolina, known and designated as Lot Fifty-seven (57) on plat of Carver Park made by Piedmont Engineering Service, October, 1951, and recorded in the R.M.C. Office for Greenville County in Plat Book "AA", page 187, and having according to said plat the following courses and distances, to wit:

Beginning at an iron pin on Waston Street (now Elder Street) joint corner of Lots 57 and 58 and running thence along the line of Lot No. 58 S. 0-19 W. 174.8 feet to an iron pin; thence along the line of the property of the Greenville Housing Authority S. 43-0 W. 73.1 feet to an iron pin; thence N. 0-19 E. 229 feet to an iron pin on Waston Street (now Elder Street); thence along the line of Waston Street (now Elder Street) S. 89-45 E. 50 feet to the beginning corner.

The lot above described is conveyed subject to the covenants and restrictions recorded in the R.M.C. Office for Greenville County in Deed Book 444, page 498, which are made a party hereof as fully as if set out herein, and to the public utility easement granted to the Duke Power Company, which is recorded in said R.M.C. Office in Deed Book 445, page 235.

The lot herein conveyed constitutes a portion of the property conveyed to me by R. M. Caine, by deed dated March 10, 1951, and recorded in the R.M.C. Office for Greenville County in Deed Book 430, page 372.
