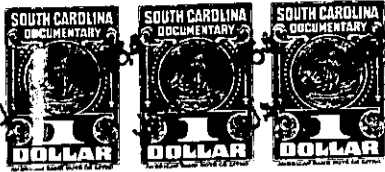

OLLIE FARNSWORTH R.M.C. Know All Men by These Presents:

That I, M. E. KELLEY in the State aforesaid, in consideration of the sum of ONE THOUSAND, FIVE HUNDRED AND NO/100 (\$1,500.00) - - - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said JAMES M. BRUCE, his heirs and assigns:

All that lot of land in Butler Township, Greenville County, South Carolina, on the Northern side of Fisher Drive, being known and designated as Lot No. 33 on Plat of Marsmen, Inc., recorded in Plat Book P, at page 5, and described as follows:

BEGINNING at an iron pin in the center of Fisher Drive, at the joint front corner of Lots Nos. 32 and 33, and running thence with the line of Lot No. 32, N. 9-12 W. 453 feet to an iron pin; thence N. 76-13 E. 100.31 feet to iron pin on a 20-foot alley; thence with the Western side of said 20-foot alley, S. 9-12 E. 461 feet to iron pin, center of Fisher Drive; thence with the center of Fisher Drive, S. 80-48 W. 100 feet to the point of beginning.

Also, all that other parcel of land adjacent to the lot above described, and to be taken from the Southwestern portion of Lot No. 32, to front 50 feet on the Northern side of Fisher Drive, and extend back in parallel lines to an old graveyard, which is approximately 100 feet in depth.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
