to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said M. G. Proffitt, his heirs and assigns forever:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, situate, lying and being in the City of Greenville, and being known and designated as lot No. 113 of Property of Central Development Corporation as shown on a Plat thereof recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book Y at Pages 148 and 149, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Stephen Lane at the joint front corner of lots 113 and 114, and running thence along the Eastern side of Stephen Lane, S. 13-19 E. 41.5 feet to an iron pin; thence continuing with the Eastern side of Stephen Lane, S. 7-49 E. 100 feet to an iron pin; thence following the curvature of Stephen Lane as it converges with Dellwood Drive, the chord of which is S. 60-15 E. 32.2 feet to an iron pin on the Western side of Dellwood Drive; thence along the Western side of Dellwood Drive, N. 43-24 E. 38 feet to an iron pin; thence continuing along the Western side of Dellwood Drive, N. 37-48 E. 63 feet to an iron pin; thence continuing along the Western side of Dellwood Drive, N. 31-18 E. 60 feet to an iron pin at the front corner of lot 129; thence along the line of that lot, following a 3 foot drainage easement, N. 62-38 W. 153.6 feet to an iron pin in the line of lot 114; thence along the line of that lot, following said drainage easement, S. 29-10 W. 91.4 feet to the beginning corner.

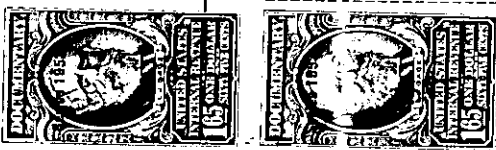
