

grantee, Lydia K. Parker, her Heirs and Assigns forever,

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Chick Springs Township, about one mile north from Taylors, kying on the east side of the Reid School-Taylors Road, being a part of the same land that was conveyed to me by deed from John W. Martin May 17th 1933, recorded in the office of the R. M. C. for Greenville County in Deed Book 193 at page 116, being bounded on the north by lot of Dave Parker, on the east by an old abandonded road and lands of Parker, on the south by other lands of myself and on the west by the said Reid School-Taylors Road, and having the following courses and distances,

Beginning on a nail and stopper in the center of the said Reid School-Taylors Road, joint corner of the Dave Parker lot, and runs thence with the Parker line N. 71-30 E. 21 feet to an iron pin, then continueing with the same course for a total distance of 142 feet to an iron pin in the west edge of the said old road; thence with the said old road, S. 36-00 E. 144.5 feet to a stake or iron pin on the west edge of the said old road; thence S. 78-15 W. 214 feet to a nail and stopper in the center of the Reid School-Taylors Road (stake or iron pin back on line on the east bank of the said road); thence with the center of the said road N. 4-23 W. 116.5 feet to the beginning corner, containing One Half (0.50) acre, more or less.
