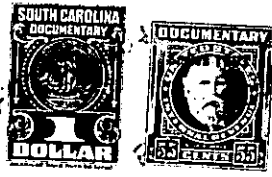

All that piece, parcel or lot of land in Greenville Township, Greenville County State of South Carolina, in the City of Greenville, described as follows:

BEGINNING at an iron pin on the east side of Judson Alley 320 feet south of the south side of Choice Avenue and running thence, N. 2 E. along said Judson Alley, fifty feet to stake; thence N. 88 1/2 E. one hundred feet along line of lot sold by D. S. Butler to W. A. Bates to an iron pin; thence S. 2 W fifty feet to stake; thence S 88 1/2 W one hundred feet to the beginning.

Being the same property which the grantor inherited from her mother, Mary Brown, as her sole heir at law and being the same property conveyed to her by Max W. Goodlett by deed dated September 7, 1931, and recorded in the R.M.C. Office for Greenville County in Deed Book 152, at Page 575.
