Know All Men by These Presents:

That I, M. W. Fore in the State aforesaid,
in consideration of the sum of ELEVEN HUNDRED & NO/100 (\$1100.00) ----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Jim D. Thomas, his heirs and assigns forever

All those pieces, parcels or lots of land in Greenville County, State of South Carolina being known and designated as Lots Nos. 208, 209 and 210 on Plat of Caroline Court, Section No. 2, recorded in the RMC Office for Greenville County in Plat Book GG at page 21 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of Marlana Avenue at the joint front corner of Lot 39 of Section 1 and No. 208 and running thence with the joint line of said lots N. 25-15 E. 240 feet to a point; thence with the rear line of Lot Nos. 207, 206 and 205, S. 64-45 E. 300 feet to a point, joint rear corner Lot Nos. 210 and 211; thence with the joint line of said lots, S. 25-15 W. 240 feet to a point on the Northern side of Marlana Avenue; thence with Marlana Avenue N. 64-45 W. 300 feet to the point of beginning.

This conveyance is subject to the following covenants, conditions and restrictions.

"That the said lands shall not be sold, rented or otherwise disposed of to any Negro or person of African descent. No residence to cost less than Seven Thousand and five hundred (\$7,500.00) Dollars shall be erected on said lots; and no residence shall be erected on lots nearer the front line than building line as shown on plat; and no residence shall be built on any lot unless said lot has 50 feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks. No business buildings shall be erected on any lot other than lots fronting on U. S. Highway #29. "

Grantee is to pay the 1954 taxes

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
