

M. D. Friar and Neeley W. Friar, their heirs and assigns forever,

ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lot No. 29 on a plat of property of J. R. West, made by Thomas T. Linder, August 16, 1937 and recorded in the RMC Office for Greenville County in Plat Book "D", at page 268 and having according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the West side of a Street, joint corner of Lots Nos. 28 and 29, and running thence with line of Lot No. 28, South 73-10 West 130 feet to an iron pin; thence North 16-50 West 67.5 feet to an iron pin, joint corner of Lots Nos. 29 and 30; thence with line of Lot No. 30, North 73-10 East 130 feet to an iron pin on the West side of said Street; thence with said Street, South 16-50 East 67.5 feet to the beginning corner.

This being the same property conveyed to the Grantor herein by Trissie Gosnell by deed dated Aug. 29, 1940 and recorded in the RMC Office for Greenville County in Deed Book 225, at page 106.
