Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. T. Merck and Delois H. Merck, their heirs and assigns forever:

All that lot of land in Greenville County, State of South Carolina, in the City of Greenville, on the North side of West Croft Street, being known and designated as the Eastern one-half of lot 42, of Section B, as shown on plat of Stone Land Company, recorded in Plat Book A at Page 237, and being more particularly described according to said plat as follows:

BEGINNING at a point in the Northern side of West Croft Street, at corner of lot now or formerly owned by Pat S.
