BEGINNING on the North side of a county road at an iron pin joint corner of Lots 7 and 8, and running along the line of Lot No. 8, N. 60-45 W. 168.2 ft. to an iron pin joint rear corner of Lots 7 and 8; thence N. 87-30 W. 24.4 ft. to an iron pin; thence S. 29-15 W. 39 ft. to an iron pin at the joint rear corner of lots 6 and 7; thence along the line of Lot No. 6, S. 60-45 E. 200 ft. to an iron pin in the county road; thence along said county road N. 29-15 E. 50 ft. to an iron pin, the beginning corner.
