Cox, his heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being the Western portion of Tract No. 2 as shown on a plat of the property of the Estate of Susan Cox recorded in Plat Book "D", at pages 14 and 15, and being more particularly described according to said plat as follows:
