Know All Men by These Presents:

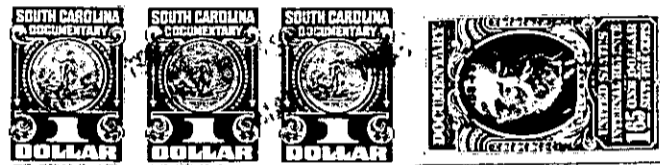
That I, Stan Lee, Jr. in the State aforesaid,

All that piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 11, Hudson Drive, as per plat thereof recorded in R. M. C. Office for Greenville County, South Carolina, in 1st Book "Y", page 38, and having, according to said plat, the following notes and bounds:

BEGINNING at an iron pin on the westerly side of Hudson Drive, joint front corner Lots 10 and 11 and running thence N. 75-10 E. 200.00 feet to an iron pin, joint rear corner lots 10 and 11; thence S. 10-00 E. 400.1 feet to an iron pin, joint rear corner lots 11 and 12; thence N. 17-40 E. 337 feet to an iron pin in the curve of Hudson Drive; thence along the curve of Hudson Drive, the chord of which is N. 17-40 E. 337 feet; thence directly North 25 feet; thence S. 7-00 E. 97 feet to an iron pin; thence along the westerly side of Hudson Drive N. 14-10 E. 100 feet to an iron pin, the point of beginning.
