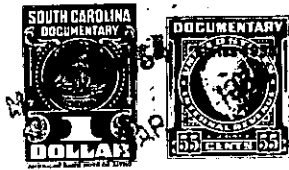

Bruce, in the State aforesaid, in consideration of the sum of ~~FOUR HUNDRED DOLLARS~~ Four Hundred (\$400.00) DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(x) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Roosevelt Robinson, his heirs and assigns forever,

All that certain piece, parcel or lot of land situate; lying and being in the County of Greenville, State aforesaid, being known and designated as Lot No. 1 according to a plat of property of P. L. Bruce prepared by R. K. Campbell, April, 1950, recorded in the Office of the Register of Menne Conveyance for Greenville County in Plat Book W, page 171, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING At a point at the intersection of a driveway and Worley Road, and running thence along said driveway, S. 34-55 W., 140 feet to a point, joint corner of Lots Nos. 1 and 3; thence along the joint line of Lot 1 and part of Lot 3, N. 55-05 W. 70 feet to a point on line of said Lot No. 3, joint corner of Lots Nos. 1 and 2; thence along the joint line of Lots Nos. 1 and 2, N. 34-55 E. 154.0 feet to a point on Worley Road, joint corner of Lots Nos. 1 and 2; thence along Worley Road, 71.90 feet to the point of beginning.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
