

2. no residence shall be erected at a cost less than \$3000.00; nor nearer than 25 ft to the front line nor shall any residence be erected on any lot unless said lot have 50 feet frontage or more.

no outside toilets are permitted and sewage must be disposed of by approved septic tank.

This deed is made subject to any rights of way which may have previously been given.
