William C. Taylor, his heirs and assigns forever:

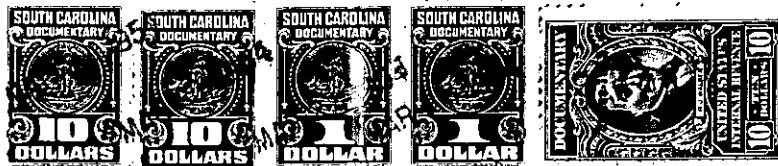
