All that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, being known and designated as Lot No. 87, Block A, of Orchard Acres, according to a plat thereof recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book BB, at page 103, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Watson Road, joint corner of Lots Nos. 87 and 88, and running thence along the joint line N. 80-41 E., 140 feet to an iron pin; thence S. 72-45 E. to an iron pin at the North-eastern rear corner of Lot No. 87; thence S. 9-19 E. 70 feet to an iron pin at the rear corner of Lots Nos. 86 and 87; thence along the joint line of those lots, N. 80-41 E. 200 feet to an iron pin on Watson Road; thence along Watson Road, N. 9-19 W. 100 feet to the beginning corner.
