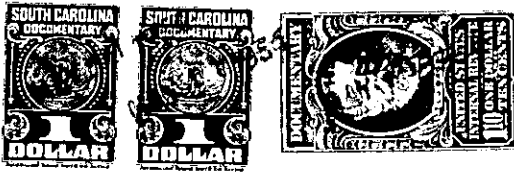

Know All Men by These Presents:

That I, A. C. Mann in the State aforesaid, in consideration of the sum of Eight Hundred Ninety-Five and No/100----- DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Earle M. Lineberger and E. M. Paul, Jr., their heirs and assigns forever:

All that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina situate, lying and being on the east side of Mayflower Avenue being Lot No. 6 as shown on Plat of Pecan Terrace recorded in the R. M. C. Office for Greenville County in Plat Book GG, page 9 and being more particularly described as follows, to-wit:

BEGINNING at an iron pin on the east side of Mayflower Avenue at the joint front corner of Lots Nos. 4 and 5; thence with the joint line of said lots S. 72-27 E. 150 feet to an iron pin; thence S. 17-35 W. 70 feet to an iron pin corner of Lot No. 7; thence with the line of that lot N. 72-27 W. 150 feet to an iron pin on the west side of Mayflower Avenue; thence with said Avenue N. 17-35 E. 70 feet to the beginning corner.

The above is part of the property conveyed to the Grantor by E. Inman, Master by deed recorded in the R. M. C. Office for Greenville County in Deed Book 140, page 108.

This lot is conveyed subject to the building restrictions as set forth on the above plat and as recorded in the R. M. C. Office for Greenville County in Deed Book 477, page 291. (Any fuel or oil tank shall be enclosed in the building structure or placed underground.)

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
