

All that lot of land situate on the east side of Rose Circle, (shown on plat hereinafter referred to as unnamed 36 foot road), in Austin Township, in Greenville County, S. C., near the road running from Mauldin to Conestee and being shown as Lot No. 17 on plat of property of E. M. and Rosa Lee Bishop, made by W. J. Riddle, Surveyor, August 1938, recorded in the R.M.C. Office for Green-ville County, S. C., in Plat Book "S", at Page 127, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of Rose Circle, at joint front corner of Lots 15 and 17 and running thence with the line of Lot 15, S. 87-30 E. 201.5 feet to an iron pin; thence S. 2-00 W. 99.8 feet to an iron pin; thence with the line of Lot 19, N. 87-30 W. 207 feet to an iron pin on the east side of Rose Circle; thence along the east side of Rose Circle, N. 5-10 E. 99.9 feet to the beginning corner.
