

J. M. Runion, his Heirs and Assigns forever,

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Chick Springs Township, about three miles northwest from Greer, S. C., lying on the northern side of the Wood Road, being bounded on the north and east by other lands of myself, on the south by the said road and on the west by lands of J. M. Runion, and being a part of the same land that was conveyed to me by deed recorded in the office of the R. M. C. for Greenville County in Deed Book 115 at page 482, and having the following courses and distances, to wit:-

Beginning on an iron pin on the south side of the said Wood Road, joint corner of J. M. Runion land, and runs thence with northern line of the J. M. Wood Estate subdivision, S. 81-30 E. 333.7 feet to a stake and iron pin in the south edge of the said road, joint corner of tracts 1,4 and 5 of the said J. M. Wood Estate subdivision; thence S. 82-30 E. 36 feet to a nail and stopper in the said road where another road intersects the Wood Road; thence with the said other road, N. 27-45 E. 163.5 feet to a nail and stopper in the center of the said road; thence a new line, N. 74-34 W. 459 feet to a stake or iron pin on the J. M. Runion line (also an iron pin on the west bank of the said other road at 16 feet); thence with the J. M. Runion line, S. 26-47 E. 103.5 feet to an iron pin, J. M. Runion corner; thence with another J. M. Runion line, S. 20-40 W. 130 feet to the beginning corner, containing One Sixty Three One-hundredths (1.63) acres, more or less.
