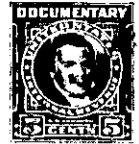

Know All Men by These Presents:

That WE, FARRELL A. ADDRESS & HAZEL H. ADDRESS,

in the State aforesaid, in consideration of the sum of Eleven Thousand Two Hundred Eighty-nine and 11/100 DOLLARS, AND ASSUMPTION OF MORTGAGE REFERRED TO BELOW to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said WILLIAM HENRY HUDSON & JANE REED HUDSON, their heirs and assigns, forever:

ALL that certain piece, parcel or tract of land with the buildings and improvements thereon, situate, lying and being on the East side of Saluda River, in Greenville Township, Greenville County, State of South Carolina, being shown as Tract 6 on Plat of Property formerly known as the Hattie Cunningham Farm, made by W.C. Riddle, Surveyor and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on a 30-foot road at the corner of Tract 5, and running thence with the line of Tract 5, N. 52-10 W., 304.4 feet to an iron pin; thence N. 34-30 E., 322 feet to an iron pin; thence S. 85-30 W., 112 feet to line of Tract 4; thence with the line of Tract 4, S. 34-30 W., 252 feet to an iron pin; thence N. 52-10 W. 100 feet to a point; thence west 400 feet to an iron pin on the bank of Saluda River; thence with the meanderings of Saluda River, S. 23-30 W. 164 feet to an iron pin; thence S. 6 W., 265 feet to a point; thence S. 16 W., 315 feet to an iron pin at the corner of Tract 12; thence with the line of Tract 12, N. 77-30 E., 309 feet to an iron pin; thence N. 80-10 E., 111 feet to an iron pin at the corner of Tract 7; thence with the line of Tract 7, N. 59 E., 603 feet to the beginning corner.

This is the same property conveyed to the Grantors by deed of George Baker and Maud Banks Wells, dated June 18, 1951, and recorded in the R.M.C. Office for Greenville County, S. C., in Deed Book 436, at page 444.

As part of the consideration of this conveyance, the Grantees assume and agree to pay the balance due on that mortgage given by George Baker Wells and Maude Banks Wells, in the original sum of \$10,000.00, to Liberty Life Insurance Company, dated May 2, 1947, recorded in the said R.M.C. Office in Mortgage Book 363, page 195. Grantees to pay 1954 taxes.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

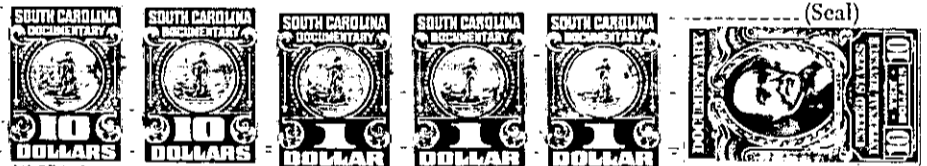
