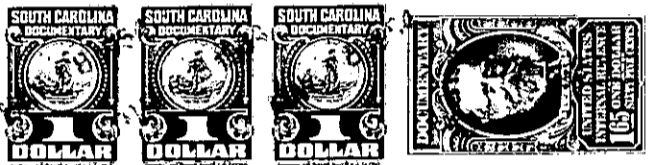

ALL that piece, parcel or tract of land in the County of Greenville, State of South Carolina, about four miles Southwest of the City of Greenville and being known and designated as Tract No. 2 on plat of property of Elsie Caldonia Reid made by C. O. Riddle, May 5, 1954 and containing 2.40 acres and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin in center of County Road and running thence North 75-07 West 19 feet to an iron pin at joint front corner of Tracts 1 and 2 and running thence along the dividing line of said Tracts 1 and 2, North 75-07 West 307.5 feet to an iron pin; running thence North 85-39 West 618.5 feet to an iron pin; running thence South 22-35 West 82.8 feet to an iron pin; running thence along the line of other property owned by the Grantor herein, South 82-58 East 577.8 feet to an iron pin; running thence South 57-02 East 285.5 feet to the edge of the County Road; running thence South 57-02 East 14.2 feet to an iron pin in the center of said County Road; running thence North 37-00 East 220.4 feet along center of said County Road to the point of beginning.
