to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

A. B. Skelton, his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina on the south side of Rocky Knoll Drive being Lot No. 76 as shown on Plat of Pecan Terrace recorded in the R. M. C. Office for Greenville County in Plat Book GG, page 9 and being more particularly described as follows, to-wit:

BEGINNING at an iron pin on the south side of Rocky Knoll Drive at joint front corner of Lots Nos. 75 and 76 and running thence with said Drive N. 25-26 W. 70 feet to an iron pin corner of Lot No. 77; thence with the line of that lot S. 64-34 W. 129.2 feet to an iron pin on right-of-way line of U. S. Highway No. 25; thence with said right-of-way S. 0-09 E. 50.2 feet to an iron pin on right-of-way of Air Base railway siding; thence with said right-of-way S. 25-26 E. 24.4 feet to an iron pin corner of Lot No. 75; thence with the line of that lot N. 64-34 E. 150 feet to the beginning corner.

This lot is conveyed subject to the building restrictions as set forth on the above plat and as recorded in the R. M. C. Office for Greenville County in Deed Book 477, page 291. (Any fuel or oil tank shall be enclosed in the building structure or placed underground.)
