to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

M. W. FORE, his heirs and assigns, forever:

ALL that piece, parcel or lot of land being known and designated as Lot No. 22 of Conestee as shown by a Plat thereof, made by Madison H. Woodward, Engineer, said lot having the courses, distances, metes and bounds, as are shown on said Plat.

BEGINNING at an iron pin at the intersection of Second Street and Sixth Avenue and running thence with the said Sixth Avenue S. 47-01 E. 126.7 feet to an iron pin; thence strill with the said Sixth Avenue S. 64-29 E. 55.8 feet to an iron pin at front corner of Lot No. 21; thence along the line of said Lot No. 21, N. 43-17 E. 51.4 feet to an iron pin at rear corner of the Baptist Church lot; thence along the line of said lot belonging to the Baptist Church, N. 46-43 W. 180 feet to an iron pin on Second Street; thence running with the said Second Street, S. 43-17 W. 68.5 feet to an iron pin at point of beginning.

THAT the said lands shall not be sold, rented or otherwise disposed of to any negro or person of African descent. No residence to cost less than Two Thousand *\$2,000.00* Dollars, shall be erected on said lot, and no residence shall be erected on said lot nearer than twenty-five (25) feet to the front line, and no residence shall be built on any lot unless said lot has fifty (50) feet, or more, frontage.



TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
