H. D. EDMS

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

All those certain lots of land in Greenville County, South Carolina, situated about one-half miles west of the City of Greenville, located and described as follows: Lots Nos. fifteen (15), sixteen (16), nineteen (19), twenty (20), thirty-two (32), according to a plat made by J. D. Miller, Surveyor, in 1911, said lots are further described as follows:

Lots Nos. 15 and 16 adjoin at their north ends and begin on the north side of Gordon Street at the beginning of said street; thence with the north side of Gordon Street N. 10-15 E., 200 feet to pin at rear corner of Lot No. 6 of said subdivision; thence with the rear line of Lots Nos. 6 and 7, S. 60-45 W., 100 feet to rear corner of Lot No. 4; thence with Lot No. 11, S. 10-15 E., 200 feet to beginning corner.

Lots Nos. 19 and 20 begin at the corner of Lot No. 18 of said subdivision and extend S. 30-15 E., 30 feet west of Curtis Road; thence S. 10-15 E., 100 feet to corner of Lot No. 21; thence S. 10-15 E., 200 feet to pin on rear line of Lot No. 3; thence with rear line of Lot No. 3, S. 10-15 E., 200 feet to pin rear corner of Lot No. 10; thence with Lot No. 10, S. 10-15 E., 200 feet to beginning corner.

Lots Nos. 31 and 32 begin on the northeastern corner of Lot No. 17, 42.1 feet as they thence line the intersection of Curtis Road and the rear line of Lot No. 17, S. 10-15 E., 100 feet to pin rear corner of Lot No. 17; thence with rear line of Lots Nos. 11, 15, 16 and 21, S. 10-15 E., 200 feet, more or less, to pin on rear line of Lot 21 at corner of said lot S. 10-15 E., 200 feet to pin on rear line of Lot 21; thence with the north side of Curtis Road; thence with the rear line of Lot No. 30-15 E., 110 feet to the beginning corner.

The small triangle across Curtis Road, which is a part of the land of the said H. D. Edms.
